For the seacan, we purchased a shelving unit to get many items off the floor and hung items on the interior walls. Much easier now to find and walk inside this unit.

Thank you to Dale Miller and Rob Bechard who have maintsined our outboard motors. At some point we should decide what to do with the 40hp outboard motor.

Through Cindy & Dale Miller our club was the receipent of a donated aluminum boat and motor which Dale has used for running races. Our club has also benefitted from a number of sailboat donations.

Tod Baudais donated his Laser with performance rigging and deck cover. Cindy & Dale Miller donated a Hobie Wave. A very big "Thank You" to these folks!!
